#### **Front Wall Discussion**

Since we now have the new information, Board would like another vote by the Association for:

- Repair the remaining brick wall
- Removing the un-repaired wall and replace it with a tiered wooden fence in its place

We will email and send a letter for a vote for each Household Homeowner (HH). We encourage Your input helps guide decisions that reflect the majority's will!

#### **Trash Can Deed Restriction Reminder**

Most neighbors follow this restriction, but some residents have expressed concerns about the inconvenience. Regardless, compliance is required.

### Two options:

- 1. Store trash cans so they are **not visible from the street**
- 2. Propose a change to the **Deed Restrictions**

To ensure compliance, the following process will be followed:

### **Violation Notices & Fines:**

- First Notice: Friendly email from the board (2 weeks to comply)
- Second Notice: Formal letter (2 more weeks to comply)
- **Third Notice:** Certified letter—\$25 certification fee + additional fine if non-compliance continues (**5 business days to comply**)
- Fourth Notice: Attorney involvement—all legal fees and fines (\$50) will be the homeowner's responsibility

## **HOA Dues & Payment Plan**

Homeowners have the option to pay HOA dues in three installments:

1st Payment: October2nd Payment: November

• 3rd & Final Payment: December

For those paying electronically, note the **surcharges**:

ACH Transactions: 1.25%Credit Card Payments: 3.00%

Additionally, **returned payments** (via check, ACH, or credit card) will incur a **\$50 fee**. **Thank You for Your Support!**
